

The Illinois Coalition for Jobs, Growth & Prosperity publishes the monthly Illinois Job Index and MSA Report as tools for elected officials, policy leaders and the public. We can better understand the Illinois economy and business climate by comparing and measuring Illinois employment growth rates against those of the Rest of the Midwest (RMW: Indiana, Iowa, Michigan, Missouri, Ohio and Wisconsin) and the Nation. Data and analysis is provided by the Illinois Economic Observatory / Regional Economics Applications Laboratory, University of Illinois. The MSA data (unless noted) were seasonally adjusted to be consistent with state totals.

	Talking Points
State, Downstate & Metro	 Illinois added 4,000 jobs at a rate of 0.07% in May 2008 improving from a revised increase of 300 jobs at 0.01% in April. This is the third time in 2008 that Illinois posted positive growth. The overall performance of Illinois was positive, while the major geographic divisions, Chicago-Downstate or Metro-Non-metro posted mixed ratings in May. Metro areas also showed variation in performance. Downstate added 6,400 jobs at 0.37% in May. Chicago, on the other hand lost 2,400 jobs at -0.06%, compared to a revised 5,600 jobs loss at -0.13% in April. This is the fourth consecutive month Chicago lost jobs. Illinois Metro lost -2,400 jobs at -0.04% in May, compared to -9,400 jobs lose at -0.17% in April. This is the fourth consecutive month Illinois Metro lost jobs. Non-Metro, however, increased 6,400 jobs at 1.22% compared to a 9,700 revised gain in April. This is the third consecutive month Illinois Non-Metro added jobs. Over the last 12-months, Illinois posted a 0.28% growth by adding 16,700 jobs. In terms of 12-months aggregated account, Metro posted a 0.03% growth by adding 1,400 jobs whereas Non-Metro added 15,300 jobs at 2.97%. Chicago added 5,700 jobs at 0.13% while Downstate added 11,000 jobs at 0.64%.
MSA page (2-4)	 Illinois Metro posted a negative growth rate of -0.04% in May by losing -2,400 jobs. Within the MSAs, five posted net loss and three posted zero growth. In terms of growth rate, four MSAs posted net improvement from April, five declined in performance, and one remained the same. The best gains in May compared to March were Rockford (-0.68% to 0.56%) followed by Kankakee (-0.22% to 0.0%) and Champaign-Urbana-Rantoul (-0.18% to 0%). Rockford gained 900 jobs at 0.56%, and Peoria added 100 jobs at 0.05%. Chicago lost 2,400 jobs at -0.06% which is the biggest loss in terms of number of jobs. Metro-East lost 500 jobs at -0.21% which is the biggest loss in terms of growth rate. Over the last 12-months, Kankakee grew the fastest at 1.36% by adding 600 jobs. Among four MSAs posting negative growth rates, Metro-East had the biggest loss of 4,800 jobs at -1.99%. While Chicago added 5,700 jobs at 0.13%, this is the smallest gain for Chicago in 12-months term since September 2004.



Talking Points					
MSA League Tables	 The most remarkable upward move in May is posted by Rockford (9th to 1st) which moved up by 8 ranks. Kankakee (8th to 3rd), Champaign-Urbana-Rantoul (6th to 4th), and Peoria (3rd to 2nd) all gained in terms of the rank from April. The deepest fall in May was experienced by Springfield from 1st position to 8th position followed by Decatur (2nd to 5th) and Davenport-Rock Island-Moline (4th to 7th). Chicago and Bloomington-Normal also lost ground in May. Metro-East had its position unchanged from April to May. In the 12-months growth league table, Decatur (3rd to 2nd), Davenport-Rock-Island-Moline (5th to 4th), Chicago (6th to 5th), and Rockford (9th to 8th) posted upward moves in May. Among the MSAs, Bloomington-Normal (4th to 6th), Peoria (2nd to 3rd), and Champaign-Urbana-Rantoul (8th to 9th) all lost ground in May in the 12-months league table. The remaining three MSAs retained their rank from April. 				

*MSA League Tables are based on revised employment data. For instances of equal growth rate for multiple MSAs ranks are decided based on change of growth rate from previous month.

Changes indicate change in rank position compared to previous month and correspond to the MSA at the right column. Rise is indicated by a '+**' and decline by a '**+**' and for an unchanged position a '**+**' is used. Figures in parenthesis indicate relative rank change from previous month.
